He holds numerous teaching awards and distinctions in the profession. In 2017, he was awarded The Texas Dental Hygiene Directors' Association and the Procter and Gamble/Oral-B Teaching Excellence Award. Then in 2008, he was inducted as an inaugural member of The University of Texas School of Dentistry at Houston's Dean's Distinguished Teaching Scholars. He was awarded the 2009 American Dental Hygienists' Association Procter and Gamble/Oral- B Educator of the Year and is a Fellow of the American Dental Education Association (ADEA), Allied Dental Leadership Development Program.
