Olga A. C. Ibsen, RDH, MS

Olga A.C. Ibsen is an Adjunct Professor at New York University College of Dentistry, in the Department of Oral and Maxillofacial Pathology, Radiology and Medicine and an Adjunct Professor at the University of Bridgeport in Bridgeport, Connecticut. She has made significant contributions to the Dental Hygiene Profession as an educator, clinician, author and editor. She has been a part of the clinical practice of Dental Hygiene for over thirty five years. She has co-authored the text "Oral Pathology for the Dental Hygienist" published by Elsevier, now in its 7th Edition. She is a contributing author to all eight editions of Mosby's Comprehensive Review of Dental Hygiene and to Mosby's Review Questions for the National Board Dental Hygiene Examination. Ms. Ibsen presents CE courses on Oral Pathology at dental and dental hygiene meetings, nationally and internationally. She is a Consultant Member to the Commission on Dental Competency Assessments where she prepares and evaluates test questions. Additionally, she serves on the editorial advisory boards for "Dimensions of Dental Hygiene" and "The Journal of Dental Hygiene." In June 2016, she received The Award for Excellence in Dental Hygiene, from the American Dental Hygienists Association.


